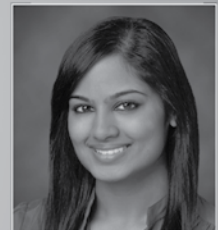

A FEW REMINDERS FROM THE OFFICE

Patty Nicholas

- 1) THERE IS **NO DUMPING** OF WASTE, TREES, SHRUBS, BRANCHES, ETC. ON DEANNE DRIVE.
- 2) **GARBAGE AND RECYCLABLE PICK UP** - ON WEDNESDAYS: Garbage is picked up at 7:30 am, recyclables after that time - make sure to have both out no later than 7:30 am to insure pick up!!!!!!! Waste Management will not be able to come back. 2 RECEPTABLES ARE REQUIRED: 1 FOR GARBAGE WITH A LID AND 1 FOR RECYCLABLES WITH A LID (all recyclables go in 1 pail), - **RECEPTACLES WITH LIDS ARE ESSENTIAL** IN THE COMMUNITY, AS GARBAGE BAGS ARE EASY ACCESS TO ANIMALS.
- 3) **SMOKE DETECTOR BATTERIES** - should be changed every six months – think daylight savings, when you change the time, change your smoke detector batteries: For Smoke Detector concerns: you can contact - Ed Stern at 786-317-6263 or Team Electric Plumbing and Air for 24 service call 800-599-8326.
- 4) **CARBON MONOXIDE DETECTOR** - for your safety and health, it may be wise to look into purchasing a carbon monoxide detector if your home does not already have one. If you do, please check the batteries so that the unit is operational. This is a device that detects the presence of carbon monoxide gas in order to prevent carbon monoxide poisoning. CO is a colorless, tasteless, and odorless gas; therefore, depending on the amount present and the length of exposure, it can be dangerous and fatal to humans. You can purchase one at any hardware store and possibly Costco.
- 5) **DRYER VENT CLEANING** – Important - have your vents cleaned periodically in order to: help reduce drying time, possible savings on utility costs and **MOST IMPORTANTLY – REDUCE FIRE HAZARD!** All venting and duct work from appliances are the unit owner’s responsibility. Jack will check the dryer vent and will replace it if needed; you must fill out a maintenance request. The unit owner must also submit a check in the amount of \$35 to LHWCA for the purchase of a new vent and hardware; the Association will install the new dryer vent. The lint removal from the dryer exhaust piping is a normal maintenance item for the appliance. Like a furnace filter it needs to be inspected and maintained on a regular basis. Follow your dryers owner’s manual for proper maintenance or call a professional, there are many listed in the Yellow pages that specialize in dryer duct and vent cleaning - or call: Lintbusters at 732-223-2980.
- 6) **MAINTENANCE REQUESTS - MANDATORY** - You must come to the office to fill one out. If the office does not have a request filled out by the homeowner resident, Jack will not be informed and there is no way to log/track necessary information regarding your unit.
- 7) **PETS--IMPORTANT**–All pets must be leashed while being walked out doors and pet walker must use **perimeter areas only**– sidewalks, curbside for walking pets. **THE COMMON GROUNDS AREA AT THE CLUBHOUSE IS NOT CONSIDERED “PERIMETER” PLEASE DO NOT WALK YOUR DOG IN THIS AREA.** You must clean up after pets wherever the pet defecates, Walker must carry a means to pick up pet litter. (Schedule A, page 48, #10, b) This means **DO NOT** let your pet run freely on common grounds. Be considerate of neighbors as well, keeping your pets off common grounds near other unit owners. **PLEASE DO NOT DISGARD PET WASTE IN THE GARBAGE RECEPTACLES AROUND POOL AREA OR AT CLUBHOUSE!!!** We are asking all residents to be aware and inform the office of those who are not cooperating as fines will be enforced, otherwise **WE WILL NOT BE ABLE TO ADDRESS THOSE IN NON COMPLIANCE.**
- 8) **DISPOSING OF MEDICATIONS** – two drop off locations: Seaside Heights Police Department, drop box is located on Sherman Avenue entrance, Toms River Police Department: Oak Avenue entrance – call 732 341-0700 Ocean County Health Department for more information.
- 9) **MOISTURE** – It is very important to make sure your home is not collecting too much moisture - which could eventually cause mold in your unit. It is advisable to keep your air conditioning running during the extreme heat in order to avoid a growth of mold in your unit. It is also advisable to have your unit checked yearly as well as other important appliances in your home that can affect your health or the condition of your unit, not only for yourself but that of your neighbor!!!
- 10) **MINIMIZING WATER DAMAGE** - Is your water heater working efficiently? It may be time for replacement. Some signs to look for: water accumulation beneath the water heater, a hissing or whistling sound (which could mean a worn valve) and/or chronic hot water shortages – these may be telltale signs of failure, if so; you should contact a licensed and insured plumber

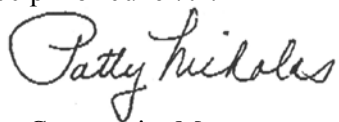
ASAP and have the water heater replaced. It is of utmost importance in order to avoid a potential problem – regularly inspect your water heater, as well as other appliances in your home that could cause any type of water damage be sure to replace aging hoses on your washing machines as well.

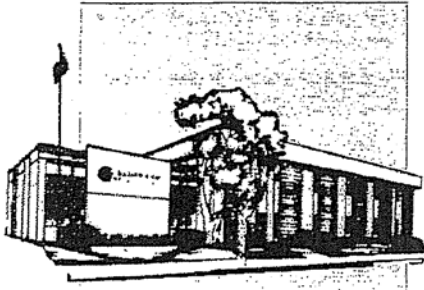
- 11) **DRAINS** – Remember - **never**; pour grease or large particles of food down your drain. Be aware of products that are not “flushable”. Over time these things can cause serious blockages in the pipes and cause the drains to back up in addition to possibly affecting your neighbor’s as well. If you are experiencing a problem with a serious back up – call a plumber immediately.
- 12) **EXTERIOR DECORATIVE OBJECTS - ARE NOT TO BE DISPLAYED ON COMMON GROUNDS** – you may **ONLY** display ornamental objects within the foundation area of your unit. Please note Page 58 of the By-Laws, Rules and Regulations - “FOUNDATION BED DECORATIONS. " NOTE: This includes reflectors, unless being used by the association or contractor to protect grassy areas from being destroyed; they may not be used for parking reasons!
- 13) **PARKING IN FRONT OF THE CLUBHOUSE IS NOT PERMITTED AT ANY TIME - THIS AREA IS AVAILABLE FOR EMERGENCY VEHICLES ONLY!! THANK YOU FOR YOUR COOPERATION.**
- 14) **PARKING** - As our streets are very narrow, parking on the side streets can create frustrating situations between neighbors, which can be avoided and easily worked out. In order to maintain peace and harmony throughout our community, we ask that you keep your neighbors in mind, use consideration when parking on the streets at all times. Please review the following:: See page 47 under SCHEDULE “A” RULES AND REGULATIONS – #19 – Parking on the street that interferes with persons backing out of their driveway is prohibited. See page 47 under SCHEDULE “A” RULES AND REGULATIONS PARKING - #1) Parking of vehicles shall be confined to the following areas:
 - a) Residents garages
 - b) Front of residents property (keeping in mind Rule and Regulation #19 mentioned above)
 - c) Residents driveway
 - d) Clubhouse parking lotAlso review, #2, specifically letter e) any vehicle parked in violation of the above rules shall be deemed in violation of the Association without notice by an authorized towing service. The expense of such action will be the homeowners. Other actions may include fines assessed to vehicle owner. Parking on common grounds is not permitted and is a

violation of the By-Laws: PAGE 47, PARKING #2, B, No Vehicles may be parked or driven on any unpaved surface i.e. lawn or any common area property except clubhouse parking lot NOTE: THE GROUNDS IN FRONT OF YOUR UNIT IS “COMMON GROUNDS” – PLEASE USE CAUTION WHEN PARKING AS NOT TO BE ON THE GRASSY AREAS!!!!!! BE ADVISED fines (\$25) will be enforced!!

Parking close to stop signs – state law mandates - you must be 50 feet away from a stop sign when parking on the street.

- 15) **LAKESWOOD TOWNSHIP TRAFFIC LAW ENFORCEMENT** - For your information, Lakewood Township has instituted “Title 39”– in our community. This means - Lakewood police department can and will patrol our community and have the right to ticket those in violation of traffic laws, such as disregard of stop signs, yield signs and SPEEDING within our community.
- 16) **MAINTENANCE FEE - PLEASE NOTE - AS OF JANUARY 1, 2015 THE MAINTENANCE FEE IS \$235.00, WHICH IS DUE ON THE 1ST OF THE MONTH** - Ten days grace is permitted as a courtesy, however, your fee must be received in the office by 1:00 pm. If the 10th falls on the weekend your maintenance IS DUE THE FRIDAY BEFORE BY 1:00 pm or will be considered late! (Notice of this policy addition was posted in the minutes for March 2012/April’s Lions Tale, additionally on a separate page in the Lions Tale, posted on the bulletin board, and appears on channel 77.)
- 17) **SUMMER MAINTENANCE PROJECTS** – Sign up - at the front office for Patio Power Wash, Front Walk Way Power Wash, and Shrub Trimming. A maintenance request is needed for power washing siding of the unit. Call the office for more information.
- 18) **REMINDER - LET’S TALK** – on the third Wednesday of each month - next one – June 15th at 7:30 pm held in the library. The discussion is hosted by Gene Cautillo, Board Trustee, Treasurer and Winni Dawson, Board President. They will address any questions, concerns or suggestions you may have concerning your community. We welcome all residents to come out to this monthly event. HOPE TO SEE YOU THERE!!
- 19) **REMINDER - TOWNSHIP OF LAKEWOOD PRIMARY ELECTION** – Vote at the Clubhouse 6:00 am to 8:00 pm on June 7th.

MEMO FROM THE MANAGER'S DESK

“ARCHITECTURAL IMPROVEMENTS GUIDELINES”

To ensure that our community will always be an attractive and a desirable place to live, architectural standards must be maintained. These standards are outlined in our By-Laws, Rules and Regulations, i.e. “Governing Documents” which have been provided to the Homeowner upon the purchase of your unit here at Lions Head Woods. It is strongly recommended that every homeowner read the Governing Documents for a full understanding of the rules, processes, and restrictions that apply to our community.

Architectural standards benefit all residents and all residents share the responsibility to comply, with support, and contribute to them. The Rules and Guidelines are not intended to unnecessarily constrain or restrict Homeowners. Instead, the purpose is to protect each Homeowner’s investment and ensure that you can all take pride in your community. The goal of these Guidelines is to provide specific, yet easy to understand guidance concerning architectural changes. As members of a condominium community with a shared interest, rather than “stand alone” homeowners, our governing documents specify what you can and cannot do to your units and in the common areas.

Applications are required for: Patios, Decks, Porches, Planting and Landscaping, Foundation Bed Decorations, Exterior Lighting, Walkways, Interior Structural Changes, Windows, Doors and Garage Doors. Prior to beginning any architectural changes, you must submit an Application to the Board of Directors for approval. An Architectural Application form is provided at the office. There are also forms located in the clubhouse above the bulletin board. The Application must be complete for review and consideration by the Board. A full description is needed along with a diagram and/or pictures as well as a certificate of liability if a contractor is to be hired. Once the application is filled out and handed into the manager’s office, a member of the Buildings and Grounds committee reviews and signs off on the application to then be reviewed and voted on by the Board at their workshop meeting held each month. The request is approved or denied by majority vote of those present. Decisions of the Board are based upon the **By-Laws**,



SCHEDULE “D” ARCHITECTURAL RULES AND REGULATIONS, pages 51-56.

For unusual circumstances or for other good cause, exceptions to the Guidelines may be made without creating a precedent. Once the application is voted on regardless of the decision, you will receive a letter from the manager. If approved, you may begin the changes upon receipt of the approved letter. Your signature is required accepting full responsibility for the work completed, and returned to the office, immediately. The change must begin within 6 months and be completed within 12 months of the approval date. If not the approval is considered lapsed and the Homeowner must reapply for the change.

Unapproved Changes: If an architectural change has been implemented prior to obtaining permission from the Board, or has otherwise violated the Governing Documents, notification in letter form will be sent to the homeowner from the office. The notification will state the violation and if applicable provide a date by which the Homeowner must either: (1) bring the property back into compliance (original condition) or (2) apply for the change. If after review of the Application the Board denies the change, the Homeowner must bring the property into compliance in accordance with the Governing Documents, unless the Homeowner appeals the decision to the Board, or requests a hearing to reconsider its decision on the Application. Under this circumstance, a Homeowner can request reconsideration only once per application. Homeowners who have corrected a violation and brought their property into compliance must provide written notification of the correction to the Board.

I hope this information was informative to you. For further detailed information, please refer to the Architectural Rules and Regulations in your By-Laws, pages 51-56. If you have any questions, please feel free to call me at the office, Monday – Friday, 9:00am to 1:00pm.

LION'S HEAD WOODS BOOK CLUB

On Monday, April 25, 2016, our loyal group of Lit Crits of the LHW Book Club met at the Clubhouse Conference Corner to discuss “*Dearie: The Remarkable Life of Julia Child*” by Bob

Spitz. The author delivered what he felt was remarkable about Julia Child in this book of well over 500 pages, but he did go overboard and made the reading tedious, especially in the second half.

Julia Child had been raised with wealth and could have lived a life of absolute leisure, but she transformed herself to an iconic cultural figure. She grew to be 6’ 3” tall and had a voice, as the book says, “like a cross between Tallulah Bankhead and a slide whistle.” She was truly unique and mastered the art of cooking - French and otherwise. She was fearless and was not intimidated by it. This was Julia’s approach to cooking.

Julia’s husband, Paul Child, was an accomplished artist, sculptor, photographer, and writer. His important position with the U. S. Government had him traveling quite a bit. Though he was extremely busy in the position he held, he always made time to direct his attention to supporting Julia’s ambitions. Paul was her biggest, lifelong fan and supporter.

Julia “discovered herself” while she was in Paris, France, with Paul on one of his trips - and in Marseille, France, she started working with fervor on her book “*Mastering the Art of French Cooking*.” She became a joyous rule-breaker, as she started the food revolution that has gripped America for more than fifty years.

Actually, “*Dearie*” is a story about a woman’s search for her own unique expression. She was rather gawky and traveled halfway around the world, working for a “spy agency” during World War II. This “spy agency” was really the OSS (Office of Strategic Services), the fore runner of the CIA. The OSS was eventually dissolved in 1945.

The author, Bob Spitz, lightheartedly admits that he had a powerful crush on Julia Child. Before her rise to fame, Julia came from a family of money in her childhood home in Pasadena, California, to college at Smith, in Northampton, Massachusetts, to work for the OSS in Washington, D.C. and overseas postings, and her travels with her husband to Ceylon, China, and France. She moved through a series of glamorous locales that were full of famous and influential people. What eventually changed everything was her discovery of French cooking - to find the perfect recipe, to know and describe exactly what should be done in turning those recipes into perfect meals.

The author shows the relationship between Julia’s persona and the vivacious larger-than-life individual behind it. The drawback is that he does so in tortured prose at times. Words are misused and he uses a lot of clichés. Repetitions are painfully misplaced and distracting. But, underneath all these negatives, the story is enthusiastically told. Phew!

This is definitely a comprehensive biography, filled with interesting, amusing, and sometimes less than flattering stories about the life of Julia Child. While the author goes on and on about how Julia researched, refined and repeated each recipe until she was convinced that she had reached its optimum level, that every detail was correct - he apparently did not take anywhere near that level of care for his own work. On a personal note, reading through such a vast amount of material, masses of trivia and inconsequential snippets, made reading a chore.

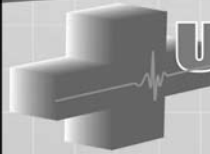

We would like to share with you information on how to protect yourself against travel scams, as provided by the New Jersey Division of Consumers Affairs, Office of the Attorney General in a *Consumer Brief*.

According to the National Association of Attorneys General, travel scams cost consumers \$12 billion annually. Unsuspecting consumers win “free” trips, which may require them to spend most of their vacation in timeshare presentations. “Free” cruises end up costing hundreds of dollars, and a “free” airline ticket may require purchase of a second ticket at an escalated price.

Fraudulent companies promote their travel packages through the mail, by phone, unsolicited e-mail, or fax. Vacations represent a real investment of both time and money, so when planning your next vacation, remember to:

- Stay away from travel offers which use high-pressure sales tactics and have deals that sound “too good to be true” because they probably are.
- Do not be pressured into making an uninformed decision or commitment. Remember, a good offer today will be available tomorrow.
- Be extremely suspicious of postcards and telemarketers which say you have been “selected” to receive a “spectacular ‘no cost’ vacation.”
- Seek the advice of a reputable travel agent and verify your arrangements before you pay.
- Buy travel insurance if it’s possible that you won’t be able to make the trip. That way you won’t lose the entire cost of the trip, only an insurance fee.
- Learn travel vocabulary like “blackout periods,” dates usually around holidays or peak seasons when you are not entitled to use travel discounts; and “subject to availability,” which means you may not be able to get the accommodations you want when you want them.
- Make sure you get all the details about your vacation in writing, especially regarding restrictions, cancellation penalties, refund policies, and additional charges like taxes and service fees. If they do not provide it, make sure to request it. Check to be sure these documents reflect the same terms to which you agreed.
- Pay by credit card. If you don’t get what you paid for, you may be able to dispute the charges with your credit card company. However, don’t provide

your account number to anyone over the phone unless you know the company he/she represents is reputable. Some telemarketers may say they need your account number for identification or verification purposes—they **don’t**. Your account number should only be used to bill you for goods or services.

- Obtain a contact number to verify your travel arrangements prior to your vacation and make sure nothing has changed (i.e. travel times, dates, check-in, air travel, etc.)
- There is additional information about charter flights, their advantages and disadvantages. If a charter flight is chosen, your rights are spelled out in an “operator/participant contract” that the operator or your travel agent should give you to sign at the time you purchase your trip.

According to the *Consumer Brief* on this subject, the Department of Transportation requires charter operators to disclose certain information in their contracts about the restrictions that they impose and also the rights that you have under its rules.

If you would like more information about charter flights, such as issues of charter flight insurance and lost luggage disputes, you can access this *Consumer Brief* at www.njconsumeraffairs.gov/a2z.htm and go to *Travel Scams*. There is also additional information on charter flights at airconsumer.ost.dot.gov/publications/charters.htm

You alone are responsible for knowing if you need a visa and passport for your trip. You can be certain about the visa and passport rules of the countries you plan to visit by calling or writing their embassies in Washington D.C. or their consulates in some major U.S. cities.

- Keep a record. Ask the full name of the travel company and record their contact information. It may also be helpful to get the name of the travel representative who is booking your trip.
- Check out the company before you buy. Contact the Division of Consumer Affairs at 800-242-5846 to see if any complaints have been lodged against the travel firm or the travel provider.
- Be aware. Fraudulent businesses often change their name to avoid any associations with past scams.
