In observance of Memorial Day, the Trust Office will be closed on Monday, May 30, 2016.

#### SPRING REMODELING SEASON

With Spring almost in full bloom, homeowners usually consider remodeling or renovating their properties. Please remember to advise your contractor that it is their responsibility to remove all construction debris and material as part of their contract. Contractors cannot dispose of any material in the Twin Rivers' bulk areas. Special pick up charges will be issued to homeowners on behalf of their contractor to recover the cost of removal of contractor debris.

Contractors are also not permitted to drive or park vehicles on the fire lanes, emergency access roads, sidewalks or any grassed areas. Damage to irrigation systems caused by contractors driving on common lawn areas will be assessed to the homeowner.

All exterior work must be inspected by the Design Review Coordinator, to insure the work was completed according to Twin Rivers' architectural standards. It is the resident's responsibility to contact the Trust Office to request an inspection, and to return the green placard to the Design Review Coordinator when the work has been completed.

It is also the responsibility of a new homeowner to contact the Trust Office about any trash or parking issues that they are unsure of. A realtor or neighbor may be misinformed about the Trust rules and regulations.

#### LAWN MAINTENANCE PROGRAM

In January 2016, your Board of Directors approved the continuation of lawn care of residential front yards. Residents who do not wish to take advantage of front lawn maintenance should complete the 2016 Request for No Mow and/or No Chemical Services Form, or call the Trust Office.

Prior to the start of the chemical treatment and mowing season, residents are asked to remove all debris from their front lawns. Your help is needed to ensure proper application of chemicals and to minimize damage to your personal property and to Trust equipment. Now is also the time to do any patch seeding to fill in any bare spots or increase the density of your front lawn. Once crabgrass pre-emergent is applied, seeding will not germinate and any seeding should be postponed until the fall.

 

Image: Margin of the safety of your neighbors and your pets, all pets must be leashed and under the control of the owner. All pet droppings must be picked up and may be disposed of in any of the track recents also and the safety of the track recents al be disposed of in any of the trash receptacles provided throughout the community. Disposal of pet droppings in the storm water drainage basins will travel into the lakes of Twin Rivers and cause contamination of the water. The cost to clean up water pollution is expensive. Your cooperation is appreciated to avoid this unnecessary cost.

East Windsor Township has an ordinance requiring residents to clean up after their pets. An Animal Control Officer enforces these regulations. Anyone observing someone not cleaning up after their pets can report the incident to the Township's Animal Control Officer.

#### **MEETING WITH THE TRUST STAFF**

The Trust Staff has an open door policy during regular business hours (9:00 am to 5:00 pm) to meet with residents. Residents who stop in will be seen on a "first come, first serve basis." Every effort will be made to meet with residents, but delays are sometimes unavoidable. If you are taking time off from work or on a limited time schedule, please call ahead and make an appointment with the person you wish to see. This will assist in scheduling and will avoid an unnecessary wait.

### **TRASH NOTICE TO ALL RESIDENTS**

## You must abide by the following rules regarding trash placement in your court. If you see anyone not complying please call the Trust Office. fines will be issued for trash put out at an improper time or location.

- Trash shall be placed out for collection no earlier than the evening (dusk) before and no later than 6:30AM the morning of your scheduled collection day.
- Household trash shall be packed securely in heavy commercially available polyethylene or similar plastic bag \*\*\*NO PAPER BAGS\*\*\*
  - ALL RECYCLED MATERIALS ARE COLLECTED IN ONE CONTAINER Do not dispose of anything that is not in the list below
- **INCLUDE**-Glass food & beverage jars and bottles (clear, green & brown) Aluminum food & beverage cans, Steel food & beverage cans, Plastic soda, water and milk bottles. Plastic detergent, shampoo & hair spray bottles (solid white or color bottles)
- Newspapers & inserts, Phone Books, Magazine, Catalogs & "junk mail", School, copier & computer paper, file folders, envelopes, Office paper. White & colored stationary, Dry food boxes, (remove liners), powdered detergent boxes, shoe & gift boxes and paper bags.

• Plastic Bags shall be placed outside your privacy fence, either in the street and/or sidewalk depending on your particular house location.

- **NO** broken glass, or light bulbs, cosmetic, medicine or perfume bottles, dishes or drinking glasses, ceramics, decorative glass, flower pots, window or mirror glass. No aluminum foil, cooking or baking dishes, No pots pans or metal scrap. No metal or plastic tools or utensils.
- No Plastic bags, paper towels, tissue or tissue paper. No pizza boxes or other food stained boxes, no frozen food boxes, or wax paper. No papers which contain plastic or foil. No Styrofoam.

#### WHAT ARE GOVERNING DOCUMENTS?

We're always talking about the association's governing documents, but what are they?

#### **State Law**

Almost every state has statutes governing condominiums and homeowner associations. In addition most associations are subject to the state corporations' code.

#### Declaration, Master Deed, or Proprietary Lease and Their Covenants and Restrictions

Planned communities are created by declarations (also known as master deeds). Cooperatives are created with proprietary leases (also called occupancy agreement). These contain the restrictions that regulate residents' behavior, they define owner's rights and obligations, and establish the association's responsibilities.

#### **Articles of Incorporation**

Most associations, and all cooperatives, incorporate and have articles of incorporation that define their purposes and powers. They may specify such things as the number of directors and their terms of office.

#### **Bylaws**

Bylaws address association operations such as procedures for meetings and elections and specifying the general duties of the board.

#### **Resolutions**—Rules and Regulations

Board members adopt rules and regulations, and sometimes members have to approve them. Rules and regulations are recorded as board resolutions. Resolutions must be consistent with the declaration or proprietary lease, the bylaws and state law.

Association governing documents are almost always trumped by state law. But, when association documents conflict among themselves, the declaration or proprietary lease carries the greatest weight, followed by the bylaws and then the rules and regulations.

#### YOUR COMMITMENT AS A HOMEOWNER

The association is glad you've found a home in our community. We presume it has all the amenities you were seeking and you're settling in nicely. This is the time the association likes to remind new homeowners that common-interest communities like ours create some unique obligations to the community and to other residents within it:

Read and comply with the community's governing **documents.** You should have received a package of documents well before you closed on your home. If you didn't, check the association's website or ask the manager or a member of the board for copies. Make sure you understand what's included in them, particularly the rules about pets, parking, your home's exterior maintenance, architectural guidelines and when you must pay association assessments.

contact information Provide current to association board members or the manager. Make sure they know how to reach you in case of an emergency, and ask them to notify you of association meetings and other important events. If you rent out your home, provide contact information for your tenants also for use in an emergency.

Maintain your property according to established standards. The community's appearance can add value to all the homes within it—including yours—so it's important to keep landscaping neatly groomed and your home's exterior well-maintained.

Treat association leaders honestly and **respectfully**. Board members are homeowners—just like you—who have volunteered to give their time and energy freely to govern the community. While you should share your concerns about the community with them, do so in a way that's constructive, informative and helpful.

Attend board meetings and vote in community elections. Board meetings are open to all who wish to sit in and keep up with issues under discussion. The association is a democracy, and your voice and vote can affect important issues.

Pay association assessments and other **obligations on time.** Your regular assessments pay for common-area maintenance, amenities and other shared expenses. If you don't pay on time, the burden for paying your portion of the association's bills, like water, electricity and trash removal, falls on your neighbors. Contact a board member or the manager, if you're having problems, to discuss alternative payment arrangements.

#### **POOL PASSES ARE CURRENTLY BEING ISSUED AT THE TRUST OFFICE**

Proof of residency is a requirement. Proof of residency is a current utility bill, which bears the resident's name and address and/or a copy of the existing lease for tenants. Adults must also bring a driver's license, passport or photo I.D.; Children 5 through 17 must have school I.D. or report card showing school attended.

The Trust staff is not authorized to issue passes for anyone not complying with this policy, regardless of personal knowledge of ownership and/or tenancy... without exception.

#### **POOL RULES**

The following rules and regulations are designed for the safety and well being of the entire community. Parents will be directly responsible for the behavior of their children, regardless of their physical presence. Anyone who presents a constant problem to the pool will have his or her pool privileges suspended. The pool manager, lifeguards and gatekeepers have full authority in enforcing these rules and regulations for all pool users. The pool manager and/or lifeguards at each pool shall have the authority and responsibility to temporarily close pools when and if for any reason they determine the use of the pool will be unsafe, i.e., storms, contamination, foreign matter in pools, unsafe chlorine readings, etc.

**ASSUMPTION OF RISK** - All persons using the pool area do so at their own risk and sole responsibility. The Homeowners Association and the Trustees of the Trust assume no responsibility for any accident or injury in connection with such use. Persons using the pool covenant and agree with the Trustees of the Trust for and in consideration of such use of the pool as an added facility to make no claim against the Trustees of the Trust for or on account of any loss of life or personal injury or damage unless it can be clearly proved to have resulted from and been caused by the direct negligence of the Trustees, their agents or employees, in the operation, care of maintenance of the facility.

NO SMOKING - The Board of Directors at the April 14, 2011 Open Public Meeting created a "No Smoking" Policy to be enforced within the confines of the pool and cabana area. Smoking is permitted outside the fenced-in area of all community

**PROPERTY DAMAGE** - The cost of any property damage will be charged to the responsible party.

#### SAFETY

- 1. No one may enter the pool without proper and valid I.D.
- 2. Proper attire is required for swimming in the pools - bathing suits only.
- 3. NO RUNNING, PUSHING OR HORSE PLAY!
- 4. No toys or artificial floatation devices, except those swimming aides approved by the lifeguard. Children under the age of six must be accompanied in the water by a parent/guardian when using any floatation device. All floatation devices are limited to the shallow end of the pool.
- 5. Parents must be present in the baby pool area at all times.

- 6. Children under the age of 11 must be accompanied by a person, 15 years old or older, to the pool. The person must remain at the pool with the children.
- 7. Children under the age of 13 must pass the deepwater swim test in order swim in the deep end of the pool. A wristband identifying the child has passed a deep water test must be worn at the pool.
- 8. No eating in pool area. Food may be consumed in designated areas only. Use of alcoholic beverages is prohibited in the pool area.
- 9. No pampers (only diapers with rubber pants or disposable swim diapers and a swim suit over them).
- **10. NO ABUSIVE OR THREATENING LANGUAGE.**
- 11. Use proper disposal of all smoking materials.
- 12. No loitering will be permitted at the entrance or cabana.
- 13. Guest passes may be purchased only by adults, 18 years of age or older, and the adult must accompany and remain with their guest at the pool.

#### FOR THE SAFETY AND PROTECTION OF **OTHER BATHERS, EMPLOYEES ARE ADVISED** TO CONTACT THE POLICE IF ANY ONE IS **CREATING A DISTURBANCE OF ANY KIND OR USING ABUSIVE LANGUAGE.**

**CHAIRS** - No one is allowed to reserve chairs for any purpose. You may bring your own chair, but it may not be left at the pool. Lounge chairs will be available at each pool.

CABANA PROPERTY - Removal of any cabana property from the cabana enclosure is prohibited.

LOST, FOUND AND ABANDONED ITEMS - Any item in these categories should be turned into the cabana office. The Trust cannot accept responsibility for any item lost, found or abandoned or clothing damaged as a result of water and/or chemical reaction.

#### PUBLIC RECREATIONAL BATHING REGULATIONS (N.J. S.S.C. 2000 8:26-5.4)

- 1. Any person showing evidence of any communicable skin disease, sore or inflamed eyes, cold, nasal or ear discharge, or any other communicable disease shall be denied admission.
- 2. Any person with excessive sunburn, open blisters, cuts or bandages shall be denied admission.
- 3. Do not enter the water if you are experiencing or recovering from diarrhea or have had any signs or symptoms of a gastrointestinal (stomach) disease in the past seven days.
- 4. All children in diapers must wear plastic pants with snug fitting elastic waist and leg bands. Do not wash out soiled diapers in the bathing water.
- 5. All children should be encouraged to use the restroom before entering the water. Immediately report any "accidents" you observe in the bathing waters to a lifeguard.
- 6. No animals, except for service animals, shall be allowed in the swimming pool, wading pool, hot tub or spa area, dressing rooms or other parts of the enclosure.
- 7. Glass containers shall be prohibited in food and drink areas.
- 8. All persons shall shower before entering the water.
- 9. Conduct, which endangers the safety and comfort of others, shall be prohibited.
- 10. Outdoor bathing shall be prohibited during an electrical storm.
- 11. Persons suspected of being under the influence of drugs or alcohol shall be prohibited from entering the water.

**PLEASE NOTE**: LISTED POOL RULES ARE SUBJECT TO REVIEW AND CHANGE-PLEASE CONTACT THE LIFEGUARDS/POOL DIRECTORS, OR THE TRUST OFFICE FOR ANY CHANGE. MANAGEMENT OR STAFF RESERVES THE RIGHT TO ASK FOR PROOF OF RESIDENCY OR PROOF OF AGE OF CHILDREN AND TO DENY ACCESS TO THE POOLS IF PROOF IS NOT ADEQUATE.

#### **GUESTS:** ALL GUESTS MUST BE ACCOMPANIED BY A TWIN RIVERS "ADULT" RESIDENT WITH A VALID ID

The resident is responsible for the conduct of their guests. At all times, guests are limited to six persons per unit address. Larger groups may be accommodated for special events upon submission at least five days in advance of the event of a Pool Party Reservation form and approval from the pool manager. Daily passes may be purchased at the pool for the cost of **\$7.00** per person weekdays and **\$7.00** per person on weekends and holidays. Guest cards may be purchased throughout the summer for the cost of **10** passes for **\$50.00** and **15** passes for **\$60.00**, from the **TRUST OFFICE.** All previous years' guest passes are still valid. Everyone five years of age and older requires a guest pass. **NO REFUNDS, NOT TRANSFERABLE.** 

A 50% discount is given for senior citizens **65 and older** with **PROOF OF STATUS.** 

#### SUMMER RESIDENT

A special summer pass is available for summer residents. This would include children over the age of 5, parents, in-laws, Mother's Helpers, etc., residing with a resident for the summer. To obtain a summer resident pass, the sponsor resident must apply to the Board of Directors for approval with a copy of their valid pool ID. Applications must be received in the Trust Office at least five business days prior to a Board of Directors Meeting. A copy of the summer resident's Driver's License, a copy of the summer resident's home phone bill and an explanation for the request must be attached to the application. If the summer resident is a minor, a copy of the parent/guardian's Driver's License, a copy of the parent/guardian's home phone bill and an explanation of the request must be attached to the application. The cost of the pass is **\$75.00**. This pass is valid for the Memorial Day through Labor Day season of issue. A summer resident under the age of 11 must be accompanied by a person, 15 years old or older, to the pool. The person must remain at the pool with the children. A summer resident cannot purchase guest passes and cannot bring guests to the pool. A Mother's Helper must have a sponsor's family member present with them to attend the pool. The penalty for falsifying a request for a summer resident pass is the sponsor family will lose their pool privileges for one year from the date of the offense. NO REFUNDS, NOT TRANSFERABLE. IF THIS PASS IS LOST, THE COST OF REPLACEMENT IS \$75.00. This pass can only be obtained from the **TRUST OFFICE**.
